5. Report on Strategic Initiatives (N. White-Johnson)

Discussion: Operations

Passages Charter Renewal: N. Johnson-White shared that we received a 2-year charter renewal with conditions. The team met with CPS to go over the renewal and deficiencies in detail and feel we have a good plan in place moving forward. We will begin charter renewal process again in April 2024

Financial

FY23 Budget Revision: N. Johnson-White reported that they are working to balance the budget based on the reduction of ECE slots/budget.

Programmatic

Enrollment: N. Johnson-White shared updated student enrollment dashboard. Enrollment is holding steady right around 300. We have an internal goal of transitioning 85% of pre-k students to kindergarten next year.

Recruitment: N. Johnson-White shared that they hosted a successful kindergarten kick-off with pre-k parents and teachers to promote our kindergarten program. 30 out of 54 parents filled out the commitment form after the meeting.

N. Johnson-White shared that there will be more recruitment events for spring and summer, including Back to Passages, to ensure we have increased numbers.

People/Culture

Personnel Updates: N. Johnson-White reported that they have continued to have turnover from pre-k through 8th grade, but the team is doing what they can to hire despite it being a hard time of year to hire.

To assist in building culture, N. Johnson-White is hosting teatime two days a week to give staff a space to share ideas and concerns.

Curriculum and Assessment Review: M. Stewart presented on what we are currently using as curriculum and assessment and what we are proposing to use in SY23-24. Passages will try and align with CPS where it's appropriate.
